



# PROTECTING THE SERVICES AUSTRALIANS **RELY ON WITH RELIABLE DATA**

How a Commonwealth Government Department built a trusted data foundation with COSOL to enable Australia's first and largest S/4HANA migration.

#### **OVERVIEW**

A significant Commonwealth Government Department underpins essential services for millions of Australians. Its systems and data support critical national programs that touch nearly every household. The reliability of these services depends on the quality of the data behind them.

But decades of legacy systems left data fragmented, inconsistent, and unreliable. Manual processes slowed decision-making. Errors risked wasting taxpayer dollars. In a sector defined by strict compliance and citizen trust, unreliable data threatened not just systems but frontline services.

As the Department prepared to migrate to SAP S/4HANA - the first and largest agency in government to take on this challenge - it needed more than a technology upgrade. It needed reliable data to protect the services Australians depend on every day. The Department chose COSOL for its proven track record in complex system migrations – including with a large Defence organisation - to make sure the foundation was right from the start.

### THE CHALLENGE

As one would expect for an organisation that has existed for over 100 years and interacts with millions of Australians, the Department faced one of the largest, most complex data transformations attempted in Australian government:

spanning HR, finance, and procurement

KPIs created to measure data health

Multiple legacy platforms with duplicated processes and manual reporting

A "brownfield" migration, where new and old systems would overlap, increasing risk

Pressure to maintain strict compliance while continuing daily operations

Mission-critical national programs had to remain always-on during migration,

Goal: Enhance the accuracy, consistency, and reliability of data before and during the transition from SAP ECC6.0 to SAPS/4HANA - without disrupting services millions rely on.







#### THE SOLUTION

COSOL, known for its deep data and SAP migration expertise, was selected to lead the Department's Data Quality Improvement (DQI) program and built a reliable data foundation.

- Delivered detailed health scores across 180+ KPIs.
- Identified gaps and designed targeted remediation.
- · Created a data health dashboard that gave all stakeholders a single source of truth to track quality in real time - a new approach for the Department.

- Applied COSOL's proprietary Data Migration Engine and Data Integration Engine (previously RPConnect) to validate and track improvements, forming the backbone for extraction, transformation, and migration.
